Registration

- Accept only Cash Payments with completed Registration forms must be submitted only to Anchorvale Community Club
- Registration by e-mail, telephone and fax will <u>NOT</u> be accepted.
- Late, unclear and incomplete forms will <u>NOT</u> be accepted.
- Participant need to fill up 1 form for 1 event. Eg, A participant that taking part in Boy U12 and U15 need to fill up 2 registration forms
- No refund of registration fee will be entertained.
- The closing date for registration is <u>30 April 2014 at 1200pm</u>
- Any event with less than **EIGHT (8)** entries will be scratched. However, the Organizing Committee reserves the right to organize the event if there is a short of entries. If the event is scratched, registration fees will be refunded.
- The organizing committee reserves the right to adjust the maximum participants without prior notice.

Eligibility of Players

- All nationality except current National Players.
- Age-groups are allowed to participate in one or more category (Max 2)

Tournament System

- No walk-over is allowed. A player will not be allowed to continue once he / she concedes a walk-over in any stage of the
 competition. All match results involving the absentee will be treated as scratched. For all the walk-over matches, prize
 money and placing shall be forfeit.
- All events will be played to best-of-5 game (11 points each) up to the final.
- Umpire will be provided from Q-Final onwards.
- Non-reporting of 15 minutes will consider a walkover.



2nd ADIDAS Table Tennis Championships 2014

Composition of All Events

- All events will be played on a round robin system followed by a single knockout system. All matches are play bet of 5.
- All seeded players for this tournament will be rank according to the 1st Adidas Table Tennis Tournament 2013 results followed by National ranking.
- Due to planning, the maximum entries are cap as stated in the Registration Form for All Events.
- The Organising Committee will close the registration of that event once the maximum entries have been received.

Draws and Fixtures

- An open draw of Championships fixtures will be conducted on 18 May 2014 at Anchorvale Community Club at 1.00pm. All are welcome to witness the draw.
- Seeding list will be announced during the draw.
- Fixtures will be displayed on Anchorvale Community Club notice board, by Friday, 6 June 2014, 2pm and will be posted on website: http://liangseng.inphosoft.com/AdidasTT/ on 6 June 2014.
- Any discrepancy or omission of entries must be brought up to the attention of Organising Committee by Wednesday, 9 June
- Draws for 2nd round will be conducted immediately after the Qualify Round and will be posted on website after the draw.

Final and Prize Presentation

- Final and the Prize Presentation Ceremony shall be held at Sengkang Sport Hall immediately after the finals of the events.
- All prize winner MUST be present at the ceremony in neat attire (no singlet, slippers and sandals) in order to receive the prize.
- All prize winners MUST be present in person, in order to receive the prize money/trophies/medals. No representatives are
- If prize winners do not turn up during the prize presentation ceremony, prize money and medals/trophies will not be awarded.

General

- The Championships shall be run in accordance with the latest rules and regulations of the International Table Tennis Federation (ITTF). Rules and regulations of the ITTF can be downloaded from www.ittf.com.
- Adidas 3-Star 40 mm white or orange balls shall be used during the Championships.
- No white apparels (shirt and shorts) are allowed. Players who fail to conform shall be disqualified.
- All players are requested to produce their Identity Card/Student Pass for verification during their registration. .
- The Organising Committee reserves the right to interpret or amend the rules and regulations of the Championships at any time without prior notification. Any other rules that are not covered by the Rules and Regulations will be decided by the Organising Committee, whose decision will be FINAL.
